



Orissa High Court commutes death penalty to life term of 2019 double murder convict

BHUBANESWAR, AUG 13

The Orissa High Court today ordered the death sentence of a man be commuted to life imprisonment for commission of a brutal double murder case in 2019, saying that

"it is well settled law that the possibility of reformation and rehabilitation of the convict is an important factor which has to be

important factor which has to be taken into account as a mitigating circumstance before sentencing him to death".

A Division Bench of Justice B.P. Routray and Justice Chittaranjan Dash taking note of the positive report of authorities. the positive report of authorities of the jail regarding the convict Niranjan Mallik in death row commuted the

commuted the capital punishment awarded by a lower court to life term.

"Taking into consideration the report of the jail authority in entirety, it cannot be said that there is no possibility of the convict being reformed and rehabilitated foreclosing the alternative tated, foreclosing the alternative of a lesser sentence", the Bench

"We are therefore inclined to convert the sentence imposed on the appellant (convict) from death to life, but taking note of the severity of the offences including murder of two persons we are of the view that the convict deserves life imprisonment for the rest of his life, the Division Bench ordered in the judgment.

The convict Niranjan on the intervening night of 16 and 17 January 2019 let loose a reign of



terror at Odagaon vegetable mar-ket in Nayagarh district and committed cold blooded murder of a night watchman, Lochan Sethi, and a 70-year-old woman, Badani Pradhan inside her house. Three other persons including the deceased Pradhan's daughter also sustained grievous injuries in the

The commission of two murders, one attempt to murder and two grievous hurts with lurking house trespass were charged against the convict under different heads prescribed in the Penal Code. A court in Nayagarh district after examining 27 witnesses and adduced 94 documents had awarded death sentence to Mallik on April 27,

Upon thorough examination of socio-economic background of the convict in the present case, it appears that he hails from the poor economic strata of society

without having any criminal antecedent and adverse report against his conduct.

As per the report of the Jail authority submitted before this court he is cordial to others and no one spoke evil of him in his village, his conduct inside the jail is normal and cordial to other inmates. Nothing on his conduct as per the report of the jail authority would constitute an aggravating factor against him to confirm the death sen-

Regardless of the heinous crime committed by him, his conduct inside jail is quite satisfactory as per the report of the Superintendent of Jail and he had also no other antecedent than the present one to be counted against him to justify his death sentence, the Division Bench stated in the 53-page

Before the meeting, board member Virginia Rivers told The Associated Press that she does not support turning the prison into an ICE facility because "I don't like what ICE stands for, how they treat the people." how they treat the people.

During the meeting, she noted that some immigrants without criminal records are being swept up by immigration agents and separated from their families. She said approving the contracts would make Mason "complicit in the abusive treatment of immigrants."

Pak's Khyber Pakhtunkhwa govt announces relief package for people displaced due to military op



PESHAWAR, Aug 13

Over 20,000 families have taken shelter due to an ongoing military operation against militants in Pakistan's Khyber Pakhtunkhwa, officials said Wednesday, as the provincial government declared a special relief package for those affected.

Security forces launched a three-day targetted operation on Monday against militants in Lowi Mamund and War Mamund tehsils in Bajaur district of the restive Khyber Pakhtunkhwa, a former stronghold of the Tehreek-e-Taliban Pakistan

Each of the displaced families

from the affected areas will receive Rs 50,000, with an additional Rs 25,000 to be paid after the completion of the targetted operation, the provincial cabinet decided on Tuesday.

On Wednesday, Additional Deputy Commissioner Bajaur Saeed Ullah Jan said that 9,132 people - 1,976 men, 2,015 women and 5,141 children – are currently housed in 116 schools and colleges.

The Sports Stadium camp alone accommodates 434 families, totalling 2,497 people, while around 20,000 families have taken refuge with relatives, with registration still in progress as of Wednesday morning.

Inspector General of Police Khyber Pakhtunkhwa Zulfigar Hameed said travel from Dera Ismail Khan to Quetta is now possible due to the improved security situation.Best vacation packages

In view of the targetted operation, around 55,000 people have been displaced since August 9 in the Bajaur district.

The authorities have not yet released information about the number of militants killed.

Every year, as the tricolour flutters in rehearsal before the formal Independence Day celebrations, Jammu and Kashmir becomes a living canvas of national identity in action. The elaborate full-dress rehearsals are more than logistical dry runs; they are symbolic reaffirmations of a shared story that bridges generations. In the districts and towns across the Valley, the sight of marching contingents, the sound of patriotic songs, and the meticulous coordination of civil and security forces create an atmosphere that transcends routine officialdom. The ceding of academic freedom in universities

Everyone engaged in higher education recognises that academic freedom is primary because universities are the places for raising doubts and asking questions about every-thing. Exploring ideas, debat-ing issues and thinking independently are essential in the quest for excellence.

After all, knowledge develops only if we question existing knowledge. This means that

students must have the freedom to ask questions just as faculty must have the freedom to question received wisdom in their respective disciplines. Indeed, universities, as insti-tutions, must have the freeto raise questions, express opinions or articulate criticisms in the wider context of economic, social and political spheres.

In fact, the development of knowledge is central to univer-sity education. Students enter the world of higher education to learn. Understanding existing knowledge is a first step. The ability to ask relevant questions, a capacity to cri-tique conventional wisdoms, the confidence to resist the authority of the spoken — even printed — word are the next successive steps. Of course, learning is a continuous process that never stops. Thus, it is for universities to decide what is taught to students, which must not be controlled from elsewhere.

There should be no restrictions on who is invited to address a student audience. Circumscribing this space, in any way, can only stifle learn-ing, which, in turn, can hurt economic and social

progress.<
The world of research needs similar freedoms. It is for universities to decide their lities. It is for faculty members to decide their research agenda. Of course, financial support for research must be based on peer review without preference or prejudice. Dissenting opinions or unorthodox thinking, irrespec-tive of disciplines, should be encouraged for that is how knowledge develops. In fact, fundamental research needs far more in terms of not only freedoms but also resources and time. Such an environ-ment is essential for brilliant scholars or thinkers to sur-

face, blossom and flourish.

The disturbing reality in India

The unfolding reality in India is disturbing. Curricula

are regulated and straitjacketed. Readings are prescribed. Indeed, what is excluded or what is included in prescribed reading lists is decided elsewhere, not necessarily by the teachers. Some readings are explicitly excluded. Promising research, which departs from the mainstream, particularly in social sciences or humanities, is stifled. Research funding is controlled, directly or indirectly, by the central government through its research councils and departments. In this milieu, fundamental research in universities in India is rare if not impossible. It is no accident that our universities have not produced any Nobel laureates.

Even the freedom for students and teachers to organise discussions or debates on campus, which are perceived as critical of the Bharatiya Janata Party or its govern-ments at the Centre and in States where it rules, is circumscribed everywhere, often by administrative fiat or penal action. Freedoms are curbed further, as social media posts sometimes lead to disciplinary action by universities or legal

action by governments.
At many Universities, if a faculty member applies for duty leave to participate in a conference abroad, he/she has to provide a written undertaking which says: "I will not participate in any anti-Government activities...while I am abroad whether on official duty or a personal visit, I shall be subect to all the provisions of Government Servants Conduct Rules including those relating to connection with the press

and criticism of Government...Further I under-stand that... any breach of these provisions whether committed in India or abroad shall render me equally liable to disciplinary action.

Such intrusion, in different forms, is now being extended to private universities. Dissenting or critical voices of students or faculty members are silenced with disciplinary action. In some cases, it goes much further, essentially ecause risk averse promoters fall in line, since they do not wish to displease or antagonise the central government, or the State governments where their universities are

Autonomy and accountabil-

Just as important, the autonomy of university spaces is also sacrosanct in the wider context of political democracy,

where universities perform an important role in addition to imparting higher education. In the economy, they are a source of ideas for science, technology, research and development, innovation, and economic or social policies. In society, they are the conscience-keepers as public intellectuals, from among the faculty, who engage with the public domain, informing citizens in their columns or lectures. In the polity, their evaluation or assessment of the performance of governments fosters accountability.

Of course, this autonomy must have a corresponding accountability. But it is essential for governments to recognise that the provision of resources to universities does not endow them with a right to exercise control.

The resources are public money for public universities, which are accountable to students and society through institutional mechanisms that exist or can be created. For this purpose, it is imperative that structures of governance in universities are appropriate for, and conducive to, accountability. Good governance is necessary but not sufficient. There must also be checks and

balances in the public domain. Rankings of universities perform an important role in this context. Such rankings, despite their limitations, provide students, their parents and society at large, such an institutional mechanism for accountability.

It is absolutely essential that regulatory structures provide complete autonomy administrative, financial and academic — to universities. Liberation from the shackles of University Commission is a necessary condition.

The existing parliamentary or legislative acts that created our universities also have many constraints and fetters Thus, as an approach, it would be far better to reform regulatory structures, provide autonomy to universities and ensure accountability through systems — rather than interventions or controls — to create an environment that encourages freedom of thought and is conducive to learning.
The quest for uniformity is

the worst enemy of thinking, creativity, understanding and knowledge, which can thrive only in open societies. One-size-fits-all is a flawed presumption. Indeed, diversity and differentiation are an inte-gral part of the quest for excelGovernments

quest to control Academic freedom in uni-

versities is circumscribed not only in India but also in countries such as Argentina, Hungary and Türkiye which have democratically elected governments. Of course, academic freedom is highly restricted in

countries that are ruled by dic-

tators in Africa and Asia. It is also curbed in countries that have one-party rule, for example, China, Russia and Vietnam. China is somewhat different. Even if the freedom for academics - especially in the social sciences and humanities — to write or to speak in the public domain is highly restricted, there is no compromise, driven by preference or prejudice, in the quality of academic appointments at leading universities and

research institutions. The real surprise is the United States, where academic freedom in universities has been sacrosanct for more than a century. The federal govern-ment of U.S. President Donald Trump is slashing research grants and imposing curbs on its leading public universities. If this continues, the leading edge of American universities in education, research, science, technology and innovation is bound to erode.

Governments seek to con-

trol universities essentially because they are worried about criticism or dissent. Just as important, there is a sense of discomfiture, if not insecurity, since universities, empowered by academic freedom, ask questions that are perceived as difficult. Of course, in some countries, governments just want ideological conformity. Most uniautonomous space because they are largely dependent on government grants to support their teaching and research. The reasons why academics, as individuals, are often silenced are because of fear or compromise, while a few are willing to trade their beliefs for rewards.

The moral of the story is simple. The absence of academic freedom in universities will inevitably harm the teaching-learning process just as it will stifle thinking and creativ-ity in research. Students and teachers will obviously be the worse-off. Ultimately, however, the economy, society and polity will be the losers.

Bullets, bombs, starvation are killing Gaza's children

Today, I am angry. I am disappointed. I write because my children are dying. Your children are dying. Our children are dying in Gaza. I can hear their strict Lore fool their pain. Why can't you?

Every day, around 30 children are killed — by bombs, missiles, and deliberate, systemic deprivation. Only two days ago, 83 Palestinians lost their lives in the Gaza Strip. Families are going days without food, leaving their orphaned children behind. Health systems have completely collapsed. Supplies have crumbled. Water is scarce. Fuel is gone. Hope is dying. Starving infants are perishing in their mothers' arms, while aid trucks sit blocked at borders. This is the gruesome face of a war that has no moral jus-

This is not merely a tragedy - it is a moral apocalypse and a brutal crime against human-

a brutal crime against numanity. And the world's institutions? The UN? Governments? They are failing.

Recent reports from the United Nations have been alarming and frightening.

Gaza stands on the brink of a famine. A quarter of the popular famine. A quarter of the population are already facing famine-like conditions and over 3,20,000 children, the entire population under five, are at risk of acute malnutrition. In Gaza City alone, child malnutrition rate has quadrupled in the last two months.

I am not an expert on the historical conflict between Israel and Palestine, nor a scholar of geopolitics and nei-ther an authority to propose a definitive solution. Certainly, the captivity and killing of innocent Israelis at the outset was unacceptable. But that does not justify the brutal retaliation on Gaza or any vio-

In 2023, when Hamas had

held innocent Israelis hostage and a war-like situation had just about begun, I knew that the repercussions would be worse than we could ever imagine. I couldn't sit back and immediately called my fellow Nobel Laureate friends, reminding them that the call for peace must come from us. On October 30, we 104 Nobel Laureates jointly made an appeal to every single Head of



sadly today, leaders are ignor-

ing the grave situation and failing the children.

Transcending borders The suffering of Gaza's children transcends borders, ideologies and conflicts. Children bear no responsibility for war. They do not drop bombs or launch rockets. They do not set policies. They hold no historical grievances. So why must they pay the ultimate price for the failures and hatred of adults? Is it their hatred of adults? Is it their crime to be born in a particular piece of land or into a family of a certain faith? Why should these innocents suffer for the acts, right or wrong, of their ancestors? Why is the lens with which we are viewing people today, and our emo-

tions and judgments so coloured by religious politics? This is the moment to speak out clearly. We must demand an immediate ceasefire to stop the killing of innocent civilians. Restrictions on food, water, fuel, and medical

Local food and grocery supply systems, bakeries, farms must be urgently restored and small vendors should be allowed to function without any fear of threats. Aid workers must be protected, never targeted or obstructed. Those weaponising starvation, blocking aid, or denying access to basics needed for survival must be held accountable under international law.

The time for merely expressing concern, hosting seminars, showing sympathy, or issuing press statements is over. We must choose between complicity and compassion. And I mean compassion not as a soft emotion or a feeling, but a transformative force born from feeling the suffering of others as one's own and taking mindful action to end that suffering. Contrary to popular belief, compassion is not a belief, compassion is not a moral ideal, but a practical and effective strategy for resolving conflicts.

There is a sliver of hope when, last month, the UK, France, and 26 other countries issued a tough statement con-demning Israel for depriving Palestinians of "human dignity". The streets are filled with protesters, shocked enraged by the scale of violence and trauma being unleashed. Several countries

Turkey, and Tunisia, have held demonstrations in the past few weeks. Other governments must also come together to produce a systematic, compre-hensive, and concrete response. The day is not very far when we will realise that power does not lie in firing missiles; power lies in compas-The voices of the innumer-

able young war survivors from Iraq, Afghanistan, and other conflict zones who I have interacted with over the years haunt me. I vividly recall an incident from some years back when I met a 10-year-old wheelchair-bound boy in a Syrian refugee camp in Germany. He had taken shel-ter along with several other children, women and men, all bearing the scars of war. During our conversation, he told me that he had lost his legs — and his father — in a bomb blast. He was separated from his mother in the chaos that followed. Overcome with grief, I had asked the child what he wants to do in future. I will never forget the conviction in his voice as he replied, "I want to study and become an engineer so that I can go back to my village that was destroyed in the war, and rebuild it." There was hope in his eyes and his dream was

Bali Bhagat slams Pakistan over anti-India remarks, warns against terror support

Senior BJP leader and former Minister Bali Bhagat strongly criticised Pakistan's leadership for their recent anti-India statements, asserting that "water and blood cannot flow together.' Speaking to reporters, Bhagat dared Pakistan to stop its support for terrorism in Jammu and Kashmir, warning that India would respond firmly to any hostile actions.

He reminded Pakistan's leaders of India's decisive military operations in the past, pointedly asking whether they had forgotten "Operation Sindoor," a testament to India's resolve in defending its sovereignty.

Bhagat reiterated that under the leadership of Prime Minister Narendra Modi, the country would never compromise on national security and would continue to act decisively against any threats emanating from across the border.

Bali Bhagat said that India today is more secure, assertive, and respected on the global stage than ever before.

Bhagat accused Pakistan of continuing its policy of cross-border terrorism and propaganda against India, despite repeated diplomatic outreach from New

"Pakistan has consistently failed to curb terrorism emanating from its soil and has shown no intent to foster peace in the region," Bhagat said. "For decades, it has tried to desta-Jammu & Kashmir through violence and misinformation. This arbitration concerns the interpretation and application of the Indus Waters Treaty to certain design elements of the run-of-river hydro-electric plants that India is permitted by the Treaty to construct on the tributaries of the Indus, Jhelum, and Chenab Rivers (the "Western Rivers")

About the overall Approach to the Interpretation of Article III and Part 3 of Annexure D the general rule is that India shall "let flow" the waters of the Western Rivers.

However, there are certain specified exceptions to this rule, including in relation to the generation of hydroelectric power, the Court said.

India's primary objection to the IWT arises out of from concerns about Pakistan's support for cross-border terrorism and its implications for India's national security and water resource management. India has linked the issue of water sharing with the broader context of bilateral relations, asserting that "blood and water cannot flow togeth-

India stresses the need to re-negotiate the treaty because of climate change and its impact on water availability. The Treaty, signed in 1960, does not adequately address the challenges posed by climate change, necessitating a renegotiation of its provisions. India argues that the Treaty's restrictions on hydropower projects, particularly on the Western Rivers (Chenab, Jhelum, and Indus), need to be revisited in light of modern dam engineering and the need for increased water storage and man-

India has formally notified Pakistan to seek modifications to the IWT, citing the need to address the issues of climate change, security concerns, and disputes over hydropower projects. India's request for modifications in and renegotiation of the Treaty based on Article XII (3) of the IWT, is being resisted by Pakistan, fearing reduction in its water share.

India does not accept the court's jurisdiction and insists on using a neutral expert mechanism.Pakistan has welcomed the Court's Award and threatened India with serious consequences if the IWT was "touched".

The application was filed by Zahoor Ahmad Bhat, an academician, and Khurshaid Ahmad Malik, a socio-political activist.

"It is submitted that the delay in the restoration of statehood would cause serious reduction of democratically elected government in Jammu and Kashmir, causing a grave violation of the idea of federalism which forms part of the basic structure of the Constitution of India," the application said.

The assembly elections and the Lok Sabha polls were conducted peacefully in Jammu and Kashmir without any incident of violence, disturbance or any security concerns being reported, it said.

Therefore, there is no impediment of security concerns, violence or any other disturbances which would hinder or prevent the grant/restoration of the status of statehood to Jammu and Kashmir as had been assured by the Union of India in the present proceedings," the plea said.

The non-restoration of the status of statehood of Jammu and Kashmir, the plea said, would result in a lesser form of elected democratic government to the state, particularly given legislative assembly results were declared on October 8, 2024.

Despite the apex court's directions for the restoration of statehood to Jammu and Kashmir "at the earliest and as soon as possible", no steps have been taken by the Centre to provide any timeline for the implementation of such directions, it

"Jammu and Kashmir is being operated as a Union Territory for a period of almost five years now, which has caused many impediments and cave losses to the development of Jammu and Kashmir and has affected the democratic rights of its citizens," the plea added.

In its December 2023 verdict, the apex court held that Article 370, which was incorporated in the Indian Constitution in 1949 to grant special status to Jammu and Kashmir, was a temporary provision. The President of India was empowered to revoke the measure in the absence of the Constituent Assembly of the erstwhile state whose term expired in 1957, the court said. (Agencies

Modi is expected to travel to China later this month to attend the SCO summit. As per the plan, Modi will embark on a visit to Japan around August 29 and after concluding the trip, he will travel to the northern Chinese city of Tianjin for the summit to be held on August 31 and September 1.

Modi's visit to China is being planned amid efforts by the two sides to repair their bilateral ties which came under severe strain following the deadly clashes between Indian and Chinese troops in Galwan Valley in June 2020. The military standoff in eastern Ladakh began in May 2020 and the clashes at the Galwan Valley in June that year resulted in a severe strain in ties.

The face-off effectively ended following completion of the disengagement process from the last two friction points of Demchok and Depsang under an agreement finalised on October 21 last year. The decision to revive various dialogue mechanisms was taken at the meeting between Modi and Xi in Kazan on October 23, 2024. The Modi-Xi meeting came two days after India and China firmed up a disengagement pact for Depsang and Demchok.

The two sides also initiated a number of initiatives to rebuild the ties that included resumption of Kailash Mansarovar Yatra and New Delhi restarting issuance of tourist visas to Chinese nationals. Both sides are also discussing modalities to resume direct flight services between the two countries.Defence Minister Rajnath Singh and External Affairs Minister S Jaishankar visited China in the last two months to attend SCO meetings. China is the current chair of the SCO.

KKGs across the districts, the Chief Secretary described the initiative as a "phenomenal programme" conceptualised by the leading national experts, with the potential to accelerate agricultural growth, enhance farmer awareness and promote best farming practices. He emphasised that every farm family should have at least one member registered with a KKG. He highlighted the unique role of these centres in delivering timely advisories, customised guidance and awareness on modern, scientific farming techniques.

To enhance their utility, the Chief Secretary directed for integrating the additional services into KKGs, including recognition as Common Service Centres (CSCs) for delivering various government services online, functioning as custom hiring centres for farm machinery and acting as Direct Selling Agents (DSAs) for banks to facilitate finan-

The Chief Secretary also asked the MD, Holistic Agriculture Development Programme (HADP), to prepare a comprehensive list of agriculture-related business ventures that Krishi Udhyamis (KUs) can establish at these centres. He asked the Deputy Commissioners to circulate success stories from the existing centres to inspire replication by others.

Reviewing the status of KKGs established under Phases I and II, he sought updates from each Deputy Commissioner on their operational readiness, including availability of IT infrastructure such as desktops, printers and broadband, as well

as licenses for sale of seeds, fertilisers and pesticides by eligible KUs.

Principal Secretary, APD, Shailendra Kumar, directed the Deputy Commissioners to set strict timelines for operationalising newly established centres, noting that KUs had already been engaged. He asked for provisioning of essential IT equipment, adoption of Point of Sale (PoS) machines for fertiliser sales and proactive public outreach to boost farmer registrations and service uptake.

MD, HADP, Sandeep Kumar, informed the meeting that under Phase I, 500 KKGs have been made operational across J&K, supported by a dedicated mobile application. Nearly, 5 lakh farmers have registered on the KKG platform, with 1.25 lakh app downloads, 96% on Android devices. Rajouri district leads in farmer registrations with over 84,000 users.

The KKG app now offers advanced features, including a decision-support system for cherry and apple growers, grievance ticket management and push notifications for advisories. A gamificationbased registration system is also in place, with 23% of registered farmers achieving Level 2 regis-

Under Phase II, 297 new centres are ready for launch in Jammu Division and 287 in Kashmir Division, significantly expanding the programme's outreach and impact. The Chief Secretary underlined that the success of the KKG initiative reflects the collaborative efforts of the administration and the farming community, aiming to strengthen the agricultural sector through technology-driven, farmer-centric solutions. By offering integrated services, knowledge dissemination and business opportunities, KKGs are poised to play a transformative role in improving farmer livelihoods across Jammu & Kashmir

why the fine had been reduced on the illegal miners, which has a limit of upto 50,000, and why it has been reduced to a minimal amount which has encouraged the illegal miners to carry on with the crime because when their stakes are in lag, they may not mind paying a small amount.

Dr Jitendra Singh said anybody found involved in illegal mining, whether he is a political high up or holding a high position, should not be spared. And should not only be booked under law, but also be publicly named and shamed.

He added that once this project becomes functional, it will provide irrigation to thousands of hectares of land, which could go up to even 90,000 hectares. For the surplus water not to be allowed to flow into Pakistan an alternate plans is also being jointly prepared by J&K, Punjab and Central Governments.

The minister informed that the last phase of Shahpur Kandi project, which is a national project that was also revised after four decades with the intervention of Prime Minister Modi, will be completed by 15th of September and the water will start flowing through that for the generation of

He emphasized that the industrial biotech park in Barnoti, which is the 11th such industrial park in the country and first in North India, will become functional in the next few weeks with the involvement of public private participation. This will create avenues of jobs, manufacturing and business for the youngsters in various areas of bio-manufacturing and hospital instruments. He added that the Government Medical College, is presently providing day care, cancer, treatment facility and there is an exercise going on to upscale this and also provide radiation treatment facilities through the experts and security of Tata Memorial Center, Mumbai.

He highlighted that the long-standing demand of Bala Sundri tunnel and the route will also be getting addressed as the government has taken up a road project from Lakhanpur to Doda via Chattra Gala Tunnel, will include this route. Once this plan is complete, the travel distance from Kathua to Billawar will be reduced only to 30, 40 minutes.

Gautam Bhai always tells me you are not aware of your own talent': Akash Deep

NEW DELHI, AUG 13

A coach who believed in him more than himself, a captain who supported when the chips were down and conditions that felt more like home than away -- Indian pacer Akash deep says his maiden but impactful tour of England was rather smooth.

A 10-wicket match-haul in one game and a very important half-century in another, both in winning causes, summed up Akash Deep's performance that has made him an overnight star but he can't forget what head coach Gautam Gambhir told him after his 66 at the Oval.

"Tumko khud pata nahi tum kya kar sakte ho (You aren't aware of your capabilities). 'See, I was telling you, you can do it. You have to play with this dedication always,'" the 29-year-old recollected in an interview to PTI.

"Gautam bhai is a very passionate coach. He always motivates us. He believes in me more than I believe in myself, both in my batting and bowling," he gushed after having earned the vote of confidence from his coach.

Having made his Test debut

coach.

Having made his Test debut under Rohit Sharma and now playing under Shubman Gill, the adjustment has been easy for the Bengal speedster, who terms the new skipper as someone who is calm yet brimming with on-field ideas.

calm yet brimming with on-field ideas.

"He is a very good captain. It's not like he is a new captain. He has already been an IPL captain for a couple of years, which is a big platform. That experience does count," he said.

"With Shubman as captain, I didn't feel like I was playing for the first time. He's very supportive. When a captain supports

the first time. He's very supportive. When a captain supports you and understands things well, especially when you are down, it makes a big difference.

"I have played Duleep Trophy under his captaincy last year so it wasn't the first time. He is a

cool customer with a lot of ideas and when someone is calm, it helps in taking good on-field decisions," Akash Deep

helps in taking good on-field decisions," Akash Deep explained.

Although it was his first time in England, Akash Deep, for the better part of the series, felt that he was playing on sub-continental tracks with negligible movement for quick bowlers.

"In Australia, there was a lot of bounce and carry and I tried keeping it slightly back of length or at times pitch it up. However, in four out of the five Tests that we played in England, it didn't



resemble the typical English wickets that we have traditionally heard of or seen over the

ly heard of or seen over the years.

"If you see, the ball wasn't seaming or swinging a lot at times and we had to hit the India length, fuller one. We had to make that adjustment which, if you have played enough cricket, you should be able to do it."

Akash Deep then dwelled on his net routines and visualisation techniques before going into an actual match.

"Practice sessions are very

an actual match.

"Practice sessions are very important for me in terms of execution. I am always trying to think about the main opposition batter that I am supposed to bowl," he revealed.

"Bhale hi main Yashasvi ko nets pe ball daloon, plan mera (Ben) Duckett aur (Joe) Root ke liye hota thaa. (I might be bowling to Yashasvi in nets but my plan was for Duckett or Root)."

When asked about concerns around his fitness after he missed games in both the tours of Australia and England due to niggles, Akash Deep said he is doing his best to be in good shape.

"The on-field impact injuries can't be avoided. If you have to

ne on-field impact injuries an't be avoided. If you have to dive to save a boundary, you have to do it. You can't think that I will hurt my shoulder and all. Yes, if it is fitness and training related injuries, the aim is to maining the man as much as pos-

ing related injuries, the aim is to minimise them as much as possible," he said.

Till now, Akash Deep has played 10 Tests and taken 28 wickets. When asked if he has been zeroed in only for the longer version of the game, Akash Deep said that he hasn't been told anything in specific.

"We can't just go and talk to selectors. They are experienced people and when they feel that they need me for any format, they would summon. My job is to perform and be ready for call

"The fancy car makes you happy, I won't deny but that's very transient. It doesn't stay after some time. Yes, my family would find joys in these achievements and I find happiness in seeing them smile. But to tell you the truth, I have never put a lot of thought into what I want to achieve," he concluded.

GSTAT passes order against Subway franchisee for not passing rate cut benefit to customer



NEW DELHI, AUG 13

In its first order in profiteering case, the newly constituted GST Appellate Tribunal (GSTAT) has held Urban Essence, a franchisee of Subway Ltd, guilty of not passing GST rate cut benefit of Rs 5.47

The Goods and Services Tax Appellate Authority (GSTAT) order dated August 5 upheld

the Directorate General Anti-profiteering (DGAP) report that Urban Essence has profiteered to the extent (DGAP) of Rs 5.47 lakh by not passing on a commensurate reduction of the prices of food products

to customers. The order in this regard was passed by President GŠTAT Justice (Retd) Sanjaya

Kumar Mishrá. The appellate tribunal directed the Punebased entity to deposit a sum of Rs 5,45,005 along with an 18 per cent interest from November 15, 2017 and deposit tha same in the consumer welfare fund in Maharashtra within 3 months.

The case pertained to a customer complaint against Urban Essence for not passing the benefit of reduction of GST rate, on restaurant services, from 18 per cent to 5 per cent with effect from November

GSTAT also looked into the issue of whether the entity was eligible to claim input tax credit (ITC) on some invoices.
The DGAP, which

investigated the case, had covered the period from November 15, 2017 to October 31, 2019, to check whether the GST rate cut bene-fits were passed to consumers.

On December 1, 2022, the Competition Commission of India (CCI) was given the responsibility to decide anti-profiteering cases under GST. Such were earlier decided by the National Anti-Profiteering Authority (NAA).

From October 2024, the Principal Bench of GSTAT has empowered to examine anti-profiteer-

AMRG & Associates Senior Partner Rajat Mohan said the DGAP vs Urban Essence decision marks the first final order from the GSTAT's anti-profiteering division, signalling that the division is now fully operational, with the President himself conducting hearings and delivering orders. "This sets the tone

for a more structured authoritative and approach to anti-profiteering enforcement under Section 171. The Tribunal's stance—upholding DGAP's findings across all products and rejecting costbased justifications reinforces that GST rate cut benefits must be directly passed on to consumers, backed by strong documentation, or face decisive action,' Mohan added.

Under Phase II, 297 new centres are ready for launch in Jammu Division and 287 in Kashmir Division, significantly expanding the programme's outreach and impact.
